TOP 3: Block of topics "Rail freight transport and logistics in the region North-East Italy

The topic block was moderated by the Vice President of FIATA and owner of the company "TransExpress" Dr. Ivan Petrov.

TOP 3.1 Development and future of the port of Trieste

Mr Crescenzi, Member of the Board of the Port Authority, presented the development and future of the port of Trieste:

- Trieste is the largest port in Italy in terms of total tonnage and at the same time the largest quantities are delivered and transported by rail.
- Trieste is the largest oil port in the Mediterranean.
- In the period from January to June 2019, more than 4000 trains have already been handled, which represents an increase of more than 7% over the previous year.
- Mr. Crescenzi presented extensive development and investment projects, including the modernisation and extension of the marshalling yard and the extension of the free port zone.
- The measures to expand the railway infrastructure are being carried out jointly and with the strong support of the Italian railway infrastructure company RFI.
- The priority in rail transport is the expansion of intermodal activities in the European area north and east of Trieste.
- The neutral railway company Adriafer, which is owned by the port, was presented.

TOP 3.2 Plans to expand railway infrastructure in Italy and in particular in northeastern Italy

Speaker: Mr de Giuseppe , Director of the Association for the Regional Railway Network in Northern Italy:

- In 2030 30% and in 2050 50% of Italy's freight volume will be transported on an extended and modernised Italian rail network.
- The main focus of the planned infrastructure development will be the Italian lines of RFC 1, 3, 5 and 6 as well as the national Italian corridors.
- Concrete objectives for larger train lengths and axle loads in the Italian network for 2021,
 2023 and subsequent years were discussed.
- Presentation of the programme for the introduction of the European Rail Traffic Management System (ERTMS) and the continuous electrification of lines.
- Concrete construction measures for the Italian sections of the RFC "Baltic Adriatic" and "Mediterranean" lines.

TOP 3.3 Experience of the Trieste logistics company "Francesco Parisi" in rail transport with the port of Trieste

Mr Daloiso, member of the management board, introduced the company and its activities in the railway sector:

- The "Francesco Parisi" Group is represented in global logistics with approximately 800 employees in 16 countries (Europe and Asia).
- Since 2009 expansion of the own terminal on Pier 6, with strong business expansion (ships handled 2017 = 235; 2011 = 110 and freight trains chartered 2017 = 1125; 2011 = 245).
- Mr Daloiso presented the master plan approved for the development of the port in 2016.
- Francesco Parisi" is a member of a consortium for the expansion of a new port terminal (123,000 m²/480 m long berth/14 m draught) to cover the rapidly growing business requirements in Trieste.

TOP 3.4 DFDS on course for expansion in the Mediterranean region

Mr. de Marco presented the developments of DFDS and especially the expansion in the Mediterranean region:

- The DFDS Group has over 8000 employees, 23 ferry routes, 8 port terminals and 35 logistics locations.
- In the Mediterranean region, 10 ferry lines are served by 10 own port terminals with 15 ships and train services on 11 routes are operated.
- An essential strategic goal is increasing cooperation and coordination within the DFDS group.
- DFDS is oriented towards an increasing number of intermodal train connections.

TOP 3.5 RCO network connects Trieste with Central Europe

Mr. Spajic introduced the company Rail Cargo Operator (RCO) and especially the development of train connections via the port of Trieste:

- RCO is a company of the Rail Cargo Austria Group responsible for intermodal transport.
- In a short time RCO has developed a Europe-wide network of train connections.
- The port of Trieste will be connected with 14 regular train connections to Central and Eastern Europe.
- While in 2014 approx. 30,000 TEU were still being transported, in 2018 more than 150,000 TEU could already be handled via the port of Trieste. A further significant increase is expected for 2019 due to the pro rata development by September.

TOP 3.6 Transport growth of liquid goods with North and East Italy

Mr. Gatti, Managing Director of ChemOil Italia, presented the development of the company in Italy:

- ChemOil, as a company of the SBB Cargo Group, has established its own network for wagon transports, "ChemLink".
- Every day, 10-12 regular block train services are provided.
- 90% of all transports are handled as dangerous goods.
- Italy is a key country for ChemOil and is served via a central marshalling yard in Mantua.
- Via Mantua, 5 main terminals in Italy are served by regular train connections.

TOP 4. Workshops of the executive board divisions

TOP 4.1 Executive Board "Digitization"

The workshop was moderated by Mr. Michael Breuer, the responsible member of the Executive Board.

At the beginning Mr. Breuer referred to the RFC-Workshop of the previous day and pointed out the importance of different digitisation measures to increase the commercial functionality on the European Rail Freight corridors. Essential requirements arise from the comprehensive information requirements of transport customers and service partners, the automation of train formation , the acceleration of transport processes, proactive control of maintenance measures and the provision of platforms for information on access points to the rail network and service offers. IBS will assist RFC managers in developing appropriate measures.



Lecture: The digital freight train of the SNCF-Fret

Mr. Rothey (SNCF Fret) and Mrs. el Radhi (Forwardis) presented the advanced system of the SNCF Fret:

- One focus of the further development of the digital freight train is the coordination of information with other transport services.
- The SNCF has already equipped 5000 wagons with TRAXENS boxes and 135 wagons with brake sample sensors.
- In order to reduce system costs and increase the profitability of rail freight transport, the SNCF is interested in increasing cooperation with service partners in the sector.
- One focus of SNCF's digitisation process is the provision of information to customers and partners of multimodal transport solutions.
- The automation of train formation, in particular the guarantee of braking systems, is an essential component for speeding up the transport process, increasing safety and reducing manual activities.
- The SNCF is engaged to providing information on "Estimated Time of Arrival" as part of a cooperation with service partners and in particular member companies of the IBS.

The IBS Executive Board will discuss the SNCF's proposals at a separate meeting.

Lecture: Logistics Web Portal of the OLTIS Group

Mr. Thomas Salamon presented the new portal developed by Jerid/OLTIS

- The new portal was developed in compliance with all TAF-TSI standards.
- The portal comprises all essential modules of the railway freight transport system chain.
- Module "Tracking and Tracing": the SIMON = System of Intelligent Monitoring was developed to guarantee complex information.
- Module "Railway Wagon Keepers": Provision of a register for wagons, locomotives and other railway equipment.



INTERNATIONAL RAIL FREIGHT BUSINESS ASSOCIATION

- Module "Railway Undertakings": a comprehensive module is provided for the railway companies for planning, operational execution, control and evaluation of the processes.
- Forwarding module: the system support already offered by OLTIS can be further developed according to the specific needs of the respective forwarding companies.
- Module for "Railway Operator": all planning, calculation and marketing processes can be controlled via this module. The generation of price lists, transport documents and the marketing of remaining capacities can also be steered via this module.
- The connection of the individual modules to the customers' IT solutions and their logistics interfaces can be supported.

- Thanks to its central geographical location, the Gernsheim location guarantees optimum conditions for the organisation of Solvadis supply flows.
- Due to its trimodal connection, the terminal is highly dynamic and flexible when it comes to organizing business processes.
- The terminal operates according to the highest security standards.
- Solvadis has planned considerable capacity expansions, for example the storage capacities are to be increased from 100 kt to 300 kt.
